



## [Terms & Conditions of Priceless Success Coaching Boot Camp](#)

### [Deposit](#)

A non refundable deposit of £80 is payable upon booking. The remainder of the fee £145 is to be paid no later than 4 weeks prior to boot camp start date.

### [Fee](#)

The amount payable by the client under the contract. The total fee excluding lunches for both days is £225

### [Booking](#)

In order to place a booking the client shall submit a completed Boot Camp Enrolment/exercise form to Priceless Success Coaching Ltd with the deposit. All bookings shall be provisional & only confirmed once the deposit has cleared.

If a booking is made by a client, the client shall be deemed to read these conditions & if the booking is made by telephone or email, the client is deemed to have signed the declaration on the enrolment form.

### [Responsibilities of the Client](#)

The fee shall not include travel to & from the location or accommodation; this shall be the sole responsibility of the client. The client shall be responsible for their own personal medical requirements, clothing & footwear for the duration of the boot camp weekend.

The client shall be responsible for advising PSC Boot Camp on the enrolment & exercise form of any health issues that may make them unable to take part in any of the physical activities & undertake physical activity knowing the potential risks. It is your responsibility to ensure that you are in good health and do not suffer from any condition(s) or physical impairment(s) which could prevent you from completing the boot camp sessions safely.

### [Cancellations](#)

If the client fails to arrive on the commencement date of boot camp the fee will be due in full to PSC Boot Camp & no refund shall be given.

The client may request to reschedule boot camp, provided they do so no later than 4 weeks before the commencement of boot camp. If I have to cancel boot camp for whatever reason a full refund will be issued within 30 days of the cancellation date.

### [Intellectual Property](#)

You may store, print and display the content supplied solely for your own personal use. You are not permitted to publish, manipulate, distribute or otherwise reproduce, in any format, any of the content or copies of the content supplied to you which are handed out, nor may you use any such content in connection with any business or commercial enterprise in any shape or form.

You shall not modify, translate, reverse engineer, decompile, disassemble or create derivative works based on any techniques, presentations, methodologies or accompanying documentation or material supplied by PSC Boot Camp.

### Force Majeure

In these conditions ('force majeure' means) unusual and unforeseeable circumstances beyond the control. PSC Boot Camp and its suppliers and consequences of which neither PSC Boot Camp nor its suppliers could avoid even if exercising all due care, events which neither PSC Boot Camp nor its suppliers, even with all due care, could foresee or forestall. It includes (but is not limited to) riot, civil unrest, war, terrorist activity and the threat of any of the foregoing, industrial dispute, natural disaster, extreme adverse weather conditions, fire and all similar events outside our control.

### Insurance

PSC Boot Camp doesn't carry insurance for loss or damage to your personal goods. This is to be arranged by yourself. PSC Boot Camp shall have no liability for loss or damage to third party property. PSC Boot Camp recommends that you take out your own personal insurance. It is advised that valuables are not brought to Boot Camp, and it is at your own risk if you do.

Failure to disclose any information on your enrolment form/exercise form, or purposely give false information may result in PSC Boot Camp terminating the agreement/contract and withdrawing the client from camp on the grounds of incorrect information given. No refunds will be given under these circumstances.
